Endeavor – You must be at least 48" to ride this ride. This is a horizontal circular ride that changes to vertical position to a height of 70'. Due to restraints some body proportions may not be able to participate.

Flying Dutchman – Riders must be at least 48" to ride. Riders will ascend to a height of over 60 feet and free fall back to the platform. Riders must ascend/descend enter and exit stairs.

Flying Jumbo – Riders must be at least 48" to ride. Riders between 39" and 48" must ride with a Supervising Companion. This is a flying Elephant ride with interactive controls that give each rider the ability to raise or lower each elephant as the wish.

Freestyle – Riders must be at least 48" to ride. This is a high speedspinning ride with front to rear and side-to-side forces. Riders must ascend/descend stairs at entry and exit.

G-Force – Riders must be at least 48" to ride and no taller than 78". Riders must sit upright. Ride is one person per car. Riders must fit within the over-the-shoulder restraint. Riders must ascend/descend two or more steps at the entrance and exit.

Ice Jet – Riders must be at least 48" to ride. Riders between 42" and 48" must ride with a supervising companion. No single riders.Guests must sit upright, hold on to the lap bar and keep hands and feet inside at all times. Larger riders sit to the outside.

Klondike – Riders must be at least 48" tall to ride. This is a high speed coaster with a loop in it. Riders must have full use of all extremities to ride.

Konga – Riders must be at least 48" to ride and no taller than 75". The Konga will give you high speed side to side movement while looking straight forward over the crowd. There is a water feature that may get you wet.

Rave Wave – Riders must be at least 48" to ride alone. Riders between 42" and 48" must ride with a supervising companion. Guests must sit upright, hold onto the lap bar and be prepared for very strong forces from all directions due to the motion of the ride. Guests must enter the ride from the side of car, which may be on an uneven surface. Riders must extend feet to the floor of the car. It is not recommended that any child under 5 ride this ride.

Silver Streak – Riders must be at least 48" to ride alone. Riders between 36" and 48" must ride with a supervising companion. Guests must sit upright and hold onto the lap bar and be prepared for very strong forces from all directions due to the motion of the ride. Guests must enter the ride from the side of the car, which may be on an uneven surface. Riders must extend feet to the floor of the car.

Sky Flyer – Riders must be at least 48" to ride alone. Riders between 42" and 48" must ride with a supervising companion. This is a swing ride that attains a height of 110' above the ground.

Storm – Riders must be 48" to ride alone. Riders between 42" and 48" must ride with supervising companion. Riders must sit upright, be restrained by a lap bar and hold onto the lap bar during the ride. Riders must withstand strong front to back and side to side forces. Riders must ascend/descend stairs at the entry and exit.

Techno Jump – Riders must be at least 48" to ride. Riders must sit upright and be restrained with waist belts and a safety bar which locks in place. Riders must hold onto the lap bar. Riders must ascend/descend entry and exit stairs.

Tilt-A-Whirl – Riders must be at least 48" to ride. Riders between 42" and 48" must ride with supervising companion. Riders must sit upright, be restrained by a lap bar and hold onto the lap bar during the ride. Riders must withstand strong front to back and side-to-side forces. Riders must ascend/descend stairs at the entry and exit. No single riders.

Twister – Riders must be at least 48" to ride this ride. This is a high speed thrill ride. There will be side to side forces as you spin round and round. Larger riders sit to the left.

Wild River – Riders must be at least 48" to ride. No single riders. Riders between 42" and 48" must ride with a supervising companion. Riders must sit upright, hold on, and maintain torso control. Riders must ascend/descend entry and exit stairs. It is not recommended that any child under 5 ride this ride.

Zipper - Riders must be at least 48" to ride. No single riders. Riders must be secured within the restraint system. Riders must hold onto the grab bars on the inside of the door with both hands when the ride is in motion. The rider must sit upright with hands and feet clear of the lap bar and door. The maximum capacity of each unit is two adults or children, with a maximum weight of 340 lbs. Riders must step up/transfer up approximately one foot into a very confined compartment and be prepared for strong forces from all directions including becoming inverted.

50" CATEGORY-

Dodgem – Riders must be at least 50" to drive and 42" to be a passenger. Riders must sit upright and be restrained by the shoulder harness, operate the foot pedals and the steering wheel. Riders must withstand jarring collisions.

52" CATEGORY-

Evolution – Riders must be at least 52" to ride. Riders will be suspended upside down during a spinning motion. You must be in full control of your arms and legs.

Extreme - Riders must be at least 52" to ride, and no taller than 78" Extreme is a high velocity swing ride that swings you from side to side reaching heights of 65' while rotating you at the same time.

Mega Drop – Riders must be at least 52" to ride. Riders will ascend to a height of 120' and free fall back to the platform. Riders must ascend/ descend, enter and exit stairs.

Remix – Riders must be at least 52" to ride. Riders must sit upright and hold onto the lap bar at all times. Riders must withstand the side-to-side and front to rear forces.

Titan – Riders must be at least 52" to ride and no taller that 78". This is a high speed thrill ride where riders will experience up to 4 G's and will reach a height of 180' off the ground. Riders must sit upright and be restrained by a shoulder harness. Due to restraints some body proportions may not be able to participate. No cell phones or loose objects are permitted on this ride.

Windsurf – Riders must be at least 52" tall to ride this ride. Riders must sit upright and alone. Riders must fit within the over the shoulder restraint. Riders must have full control of their arms and legs.

54" CATEGORY-

Grand Wheel – Riders must be at least 54" to ride alone. Riders between 42" and 54" must ride with supervising companion. Riders must sit upright and have control of their extremities. Riders must ascend/descend stairs at entry and exit. Children under the age of 5 are not permitted to ride this ride. No single riders.

Galaxy Coaster – Riders must be at least 54" tall to ride this ride. Riders must sit upright. Riders must fit within the over the shoulder restraint. Riders must have full control of their arms and legs. Ascend/ descend stairs.

Insanity – Riders must be at least 54" tall and no taller than 78" to ride this ride. This high action ride takes you up to 80' in the air. Riders must sit upright. Ride is one person per car. Riders must fit within the over the shoulder restraint. Riders must ascend/descend two or more steps at entrance and exit.

La Grande XL – Riders must be at least 54" to ride alone. Riders under 54" must ride with a supervising companion. Riders must sit upright without assistance and climb steps or step up/transfer up into the gondola. No single riders.

OMG – Riders must be at least 54" tall to ride. Riders must sit upright and alone. Riders must fit within the over the shoulder restraint. Riders must have full control of their arms and legs.

Sky Ride - Riders must be 54" to ride alone. Riders between 42" and 54"

must ride with a supervising companion. Riders must sit back in the seat and hold onto the lap bar. Since the ride does not normally come to a complete stop for loading and unloading, adults accompanying children must help their children in and out of the chair. Riders must lift themselves or be lifted by a companion into the chair and must hold on, sit still and erect. If riders require additional time for boarding, notify the ride operator. Children under the age of 5 are not permitted to ride this ride.

Tango – Riders must be at least 54" to ride. Riders must sit upright and alone. Riders must fit within the over the shoulder restraint. Riders must have full control of their arms and legs to ride.

The Big Wheel – Riders must be at least 54" to ride. Riders between 42" and 54" must ride with supervising companion. Riders must sit upright and have control of their extremities. Riders must ascend/ descend stairs at entry and exit. Children under the age of 5 are not permitted to ride this ride. No single riders.

56" CATEGORY-

Mach 1 – Riders must be at least 56" and no taller than 75" to ride. This is a high, speed thrill ride where riders will experience 3.5 G's. Ride stands 120 feet tall. Riders must sit upright and be restrained by shoulder harness. Riders must ascend/descend entry and exit steps. **Speed** – Riders must be at least 56" and no taller than 75" to ride.

This is a high, speed thrill ride where riders will experience 3.5 G's. Ride stands 120 feet tall. Riders must sit upright and be restrained by shoulder harness. Riders must ascend/descend entry and exit steps.

ATTRACTION -

Super Bungee – Weight limit 80–300 pounds. Under 16 years of age must have parent or legal guardian consent. All riders must sign guest waiver and release form. Riders must ascend/descend two or more steps entering and exiting basket. Riders must fit safely and comfortably with all safety harnesses to participate. Riders will experience g-forces that take them to 130 feet. Please watch action of the ride and know your limit.

CONCESSIONS (FOOD AND GAMES) AND MIDWAY GUIDELINES

All concessions on the RCS midway have either accessible counters or supplemental counters with clipboards for transactions. Employees are trained to anticipate the needs of patrons, especially those with obvious limitations. They will not hesitate to come out from behind the counter to serve you. If there is something that you need, feel free to ask. Please come to the counter, and an employee will come out to take your order and serve you. Wheelchair accessible tables are located throughout the midway. Please see ADA Accessible Guidelines.

Please report any safety concerns you observe or are told about to our Guest Services Booth immediately so they can be addressed quickly. We appreciate your help in keeping our carnival safe and fun.

FAST PASS PROGRAM

For your convenience we have now equipped all our RCS Rides with a "Fast Pass Lane" (indicated by black and white checkered flooring and signs). You can now purchase a pass to skip to the front of the line and double the amount of rides during your visit. 25% of all ride seats will be dedicated to the Fast Pass customers. Grab yours today at any ticket booth. (Every rider must have their own Fast Pass lanyard and the appropriate Fast Pass daily wristband securely attached).

Fast Pass also requires appropriate amount of ride tickets.

SAFE RIDE RULES & HEIGHT REQUIREMENTS





WELCOME!

elcome to the Ray Cammack Shows Carnival Midway! We hope you enjoy your day with us!

The purpose of the Safe Ride Rules and Height Requirements is to assist all of our patrons in finding the rides or attractions that best suit them. As there are many types of thrills at the carnival, there are many types of interests and abilities that our patrons enjoy. Parents, you know your children best. Please evaluate the rides your child wants to ride and be sure they understand and are able to follow the rules to enjoy the action of the ride. It is important for their safety that they obey the rules of the rides they have selected. **Parents and/** or supervising companions if your children are too afraid, please wait until next year. Please select rides for them that are within their capabilities and have them observe the action of the ride before they board.

Parents, if you are not riding with your child and the ride rules/ guidelines call for a supervising companion for your child, be sure the person you select is capable of supervising your child at all times. They must explain the rules to your child, and follow the rules themselves. This person must be at least 14 years of age and meet the height requirement of the ride. All riders, including Supervising Companions, are required to have tickets to ride.

ADA guidelines are available at any RCS Guest Service.

Please do not ride our rides if you are impaired by alcohol, drugs, or any other substance.

Should you have any questions or comments please advise us and we will be happy to assist you.

GENERAL GUIDELINES

General provisions are health-related and ergonomic advisories relate to virtually every ride and attraction. Rather than itemize them individually for each ride they are set forth generally below:

- Please observe all signs and comply with operator instructions. Please review the height restrictions and ride rules so you can comply. Some attractions do not allow open toe shoes. Some rides do not allow single riders.
- Observe the speed, height and motion of each ride or attraction. Do not participate unless you have the ability to ride safely.
- Food, Drinks and Smoking are not allowed on the rides as well as sharp or pointed objects. **Secure all loose objects** or items of clothing. We are not responsible for lost or stolen items.
- Please secure Cell Phones, Keys, Hats, Glasses and all loose items. You may be held liable for loss or injury to any bystanders from flying objects you fail to secure. We are not responsible for lost or stolen articles. The use of Selfie Sticks is prohibited on all rides.
- You know the state of your health best. Be personally responsible for not participating in any activity that could harm your health including a heart condition or high blood pressure; neck, back or bone disorder; nerve disorder, seizure, dizziness or motion sickness; recent surgery, illness or restrictive medication; or any other ailment which amusement ride or attraction participation may aggravate.
- Pregnant women are advised not to participate on rides.
- We do not recommend any child under the age of two participate on any of our rides. Some additional rides may have other age requirements.
- Observe and use all passenger restraint devices including holding on. Please wait for operators to open or close lap bars or passenger restraints. If you physically cannot be comfortably restrained or hold on, advise the ride operator and disembark from the ride. Due to the design of some restraints certain body proportions may not be able to participate on those rides.

- Secure all Pre Sale Tickets, Fun Passes and Fast Passes, there are No Refunds or Exchanges if they are lost or stolen.
- Be cautious upon entering and exiting rides and attractions. You may be light headed or encounter a surface you don't remember.
- Ask for assistance if ever you need it. A Guest Services booth is available to serve you, as are knowledgeable carnival employees.

INDIVIDUAL RCS SAFE RIDE RULES AND ATTRACTIONS REQUIREMENTS

This brochure outlines the safe rider requirements of each individual ride and attraction on an RCS Midway. Categories are general. Each ride/ attraction has specific qualifications and rules.

32" CATEGORY-

Farm Tractors – Riders must be at least 32" to ride. Riders must sit upright. Riders ride alone and entry into the ride requires negotiating elevated steps. Children only.

VW Bugs – Riders must be at least 32" to ride. Riders must sit upright. Riders ride alone and entry into the ride requires negotiating elevated steps. Children only.

34" CATEGORY-

Motorcycles – Riders must be at least 34" to ride and no taller than 54" maximum rider height. Riders must sit upright. Riders ride alone and entry into the ride requires negotiating elevated steps. Children only.

Guad Ride – Riders must be at least 34" to ride and no taller than 54" maximum rider height. Riders must sit upright. Riders ride alone and entry into the ride requires negotiating elevated steps. Children only.

36" CATEGORY-

Clown Glasshouse – Participants must be at least 36" to enter this fun house. Participants must walk alone and upright. Participants must ascend/descend stairs at entry and exit.

Groovy Bus Train – Riders must be at least 36" tall and a minimum of 3 years old to ride. Riders must fit in a small seat, sit upright and hold on. Riders must step/transfer into the train.

Happy Train – Riders must be at least 36" to ride. Riders must fit in a small seat, sit upright and hold on. Riders must step up/transfer into the train. It is not recommended that any child under 3 ride this ride. Children only.

Little Dipper – Riders must be at least 36" to ride. Riders must ascend/ descend entry and exit stairs. Riders must step up and over to enter the ride compartment and must sit upright.

Mini Bumper Cars – Riders must be at least 36" to ride. Riders control the action of the cars.

Speedway – Riders must be 36" to ride this ride alone. Riders under 36" must ride with a supervising companion.

Spider Mania – Riders must be at least 36" to ride and no taller than 60" max. **Survival Island** – Participants must be at least 36" to participate. Children Only. Participants must ascend/descend steps to enter and exit. Participants must walk alone and upright to negotiate a tunnel, a slide, a bridge, hanging punching bags, etc. Maximum height 50".

Tea Cups – Riders must be at least 36" to ride and not taller than 56". Ride will spin while each cup is self-propelled.

Up Up and Away (Balloon Ride) – Riders must be at least 36" to participate. Riders will spin while each tub is self-propelled.

Wiggle Wurm – You must be At least 36" to ride this ride alone. Riders between 32" and 36" must ride with a Supervising Companion. This is a circular ride with up and down motion. Must be able to sit in seat and hold on.

39" CATEGORY-

Baja Buggy – Riders must be at least 39" to ride this ride. Riders must step up into the ride vehicle and hold on. Riders must sit upright in a small seat.

42" CATEGORY

Carousel – Riders must be at least 42" to ride alone. Riders under 42" must ride with a supervising companion. Riders must sit upright, and hold onto the horses. Riders must step up to platform twice. Bench style seats are also available. Riders must step up and off an uneven platform.

Creep Show – Riders must be at least 42" to ride alone. Riders between 36" and 42" must ride with a supervising companion. Riders must sit upright and hold on. Riders must ascend/descend stairs or narrow ramp at entry and exit.

Dizzy Dragon – Riders must be at least 42" to ride alone. Riders between 36" and 42" must ride with a supervising companion. Riders must sit upright, and entry into the ride car requires negotiating elevated steps.

Euroslide – You must be at least 42" to ride alone. Riders between 36" and 42" must ride with a supervising companion. Riders between 3 and 8 years of age must ride with a supervising companion and must meet height requirements. Riders must sit upright and must slide feet first.

Fun Factory – Participants must be at least 42" to participate in this fun house attraction. Participants must walk alone and upright through obstacles such as barrels, punching bags and moving walkways. Participants must ascend and descend a short flight of stairs to enter and exit.

German Fun House – Participants must be 42" to enter this funhouse alone. Participants 36" to 42" must be with supervising companion. Participants must walk alone and upright on obstacles such as moving stairs and floor ways. Participants must ascend/descend a short flight of stairs to enter and exit.

Goliath Slide – Riders must be at least 42" to ride alone. Riders between 36" and 42" must ride with a supervising companion. Riders must sit upright and must slide feet first. It is not recommended that any child under 3 ride this ride.

Haunted Mansion – Riders must be at least 42" to ride. Riders must sit upright and hold on. Riders must ascend/descend stairs or narrow ramp at entry and exit.

Kite Flyer – Riders must be at least 42" to ride. Riders must step up into the kite into a prone position and be flat. Riders must withstand a spinning ride that turns at a high rate of speed. Each kite holds a maximum of 275 lbs. It is not recommended that any child under 3 ride this ride.

Merry-Go-Round – Riders must be at least 42" to ride alone. Riders under 42" must ride with supervising companion. Riders must sit upright and must hold on to horses with seat belt secured. Bench style seats are also available. Riders must step up and off uneven platform. Wheel chair ramp available.

Monkey Maze – Participants must be at least 42" to participate alone. Participants between 36" and 42", must be accompanied by a supervising companion. Participants must walk alone and upright on obstacles such as mazes and mirrors. Participants must enter by ascending and descending a ramp or stairway.

Monster Trucks – Riders must be 42" to ride alone. Riders between 36" and 42" must ride with a supervising companion.

Pelican Splash – Riders must me at least 42" tall to ride this ride alone. Riders between 36"and 42" must ride with a Supervising Companion. Riders must sit upright and maintain torso control. Riders must ascend/ descend stairs.

Pirates Island – Riders must be at least 42" to ride alone. Riders between 36" and 42" must ride with a supervising companion. Participants must stand, walk, climb, and slide alone on their backs.

Puppy Roll – Riders must be at least 42" to ride alone. Riders between 36" and 42" must ride with a Supervising Companion. Ride will spin while each Puppy is self propelled. Riders must sit upright and entry into the ride requires negotiating elevated steps.

Rockin Rodeo – Participants must be at least 42" to participate alone. Participants between 36" and 42" must be accompanied by a supervising companion. Participants must walk alone and upright thru obstacles such as mazes and mirrors. Participants must enter by ascending stairs and descend a slide. **Rockin Tug** – Riders must be at least 42" to ride alone. Riders between 36" and 42" must ride with a supervising companion. Riders must fit a small seat and sit upright. They must also step up into the vehicle, and hold on. Participants must ascend and descend a short flight of stairs.

Silly Sea – Participants must be at least 42" to ride. Participants must walk alone and upright on obstacles. Participants must ascend and descend a short flight of stairs to enter and exit.

Super Slide – Riders must be 42" to ride alone. Riders between 36" and 42" must ride with a supervising companion. Riders must climb a moderately steep ramp to the top of the slide. Riders must sit up and maintain a seated position while riding down the slide feet first. It is not recommended that any child under 3 ride this ride.

Surf Shack – Participants must be at least 42" to enter this funhouse attraction. Participants must walk alone and upright on obstacles such as moving stairs and floor ways. Participants must ascend and descend a short flight of stairs to enter and exit.

Wacky Worm – Riders must be at least 42" to ride alone. Riders between 36"and 42" must ride with a Supervising Companion. Riders must sit upright and hold onto the lap bars. This is a family coaster.

Zero Gravity – Riders must be at least 42" to ride and must stand upright and alone during this spinning ride. Riders must ascend/ descend stairs at entry and exit

46" CATEGORY-

Sling Shot – Riders must be at least 46" to ride alone. Riders between 43" and 46" must ride with supervising companion. Combined load minimum is 150 lbs. Eject from 0 to 80 mph in 1.2 seconds to a height of 200+ feet.

48" CATEGORY-

#16 Ferris Wheel – Riders must be at least 48" to ride. No single riders. Riders between 42" and 48" must ride with supervising companion. Riders must assume a proper riding posture without the aid of another guest during the operating cycle. A proper riding posture is one in which the rider has their back against the seat and holds onto the handle bar without assistance. Riders must use the lap bar as designed (the lap bar must close). Riders must ascend/descend stairs at entry and exit. It is not recommended that any child under 3 ride this ride.

Airmaxx – Riders must be at least 48" to ride. Riders should expect strong side to side forces and be in full control of their arms and legs. Riders must ascend/descent entry and exit steps, enter the seat from a sloped platform, and fit within the over-the-shoulder safety restraint.

Alien Abduction – Riders must be at least 48" to ride. Riders must stand upright and alone throughout this spinning ride. Riders must ascend/descend entry and exit stairs.

Big Top Swinger – Riders must be at least 48"to ride. This is a swing ride that attains a height of 60' above the ground.

Centrifuge – Riders must be at least 48" to ride. Riders must stand upright and alone throughout this spinning ride. Riders must ascend/ descend entry and exit steps.

Cliff Hanger – Riders must be at least 48" to ride. Riders must climb up on to the ride into a prone position and be flat. Riders must be able to withstand a spinning ride that turns at a high rate of speed.

Crazy Coaster – Riders must be at least 48" to ride alone. Riders between 42" and 48" must ride with a supervising companion. Riders must sit upright with their back and head pressed against the backrest and hold on to the lap bar at all times. Riders must ascend/descend stairs at the entry and exit.

Cyclone – Riders must be at least 48" to ride alone. Riders between 42" and 48" must ride with a supervising companion. Riders must sit upright while holding a lap bar, and have the ability to withstand the spinning forces. Riders must step up into the ride pod.

Disk'O – Riders must be at least 48" to ride. This is a high speedspinning ride with front to rear and side-to-side forces. Riders must ascend/descend stairs at entry and exit.
